The Metropolitan Magistrate 25th Court, Mazgaon, At Sewree Mumbai passed order on 24.02.2022 in a complaint filed by Supreme Court advocate Adv. Ravi Prakash Jadhav earlier as a Party in Person in which the Hon. Court directed Senior Police Inspector, Azad Maidan Police Station to investigate offences under Sections 153, 153 A, 153 B, 188, 220 B, 269, 270, 271, 341, 500, 504, 505 (ii), 506 r/w Section 34 of the Indian Penal Code & for violations of Epidemic and Pandemic Laws against

1) Mr. Anil Bonde- Ex- Minister Agriculture, Ex- MLA, Morshi (BJP Leader) (Accused No. 1),

2) Mr. Sujit Jogas, BJP Yuva Morcha, Jalna District President – MLA, Nagpur (East) (Accused No. 2),

3) Mr. Krishna Pancham Khopade MLA Nagpur & BP Leader and Others for Threatening and making derogatory remarks, Criminal Conspiracy, promoting enmity amongst the two groups and in society, derogatory speech, restraining lawful authority & disturbing peace in the society , and violations of Covid-19 rules etc. against Shri. Nana Patole (President – Maharashtra Pradesh Congress Committee) and people of Maharashtra and thereby further the Hon. court directed Sr. PI, Azad Maidan Police Station to submit its report till 23.03.2022.

The matter before Metropolitan Magistrate 25th Court, Mazgaon, At Sewree Mumbai kept on 23.03.2022 for report.

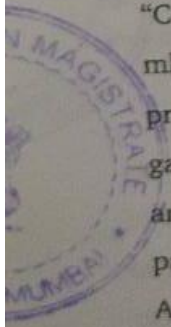

ORDER BELOW EXH. 1 IN C.C. No.103/MISC/2022

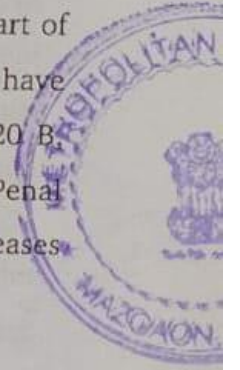
The complainant has filed complaint submitting that he is the practicing advocate and member of Supreme Court Bar Association. He is practicing various Honorable High Courts and Honourable Supreme Courts. He is filing this complaint as parting person's. He is also National Joint Coordinator of Indian Youth Congress (Legal Cell) and working as Mumbai Congress-Legal, Human Right, RTI Department. Accused No.1 is Leader of BJP and resident of Amaravati, accused No.2 is the Leader of Bhartiya Janta Yuva Morcha, Jalna District President. Accused No.3 is the Leader of BJP and he is MLA from Nagpur (E), Maharashtra, accused No. 4 is unknown person. It is alleged by the complainant that accused No.1 intentionally participated in agitation and gave media bites in Amaravati on 18/01/2022 saying that "Congress madhe hod lagali aahe--- Nana chavnyachi dhamki detoy, mhanje malkinila tyala siddha karayche ki, mi sadha kutra nahi ekdam pramanik kutra aahe, pan nananni he lakshat thevale pahije ki asha ganja marnarya shahisthekhanchi bote Maharashtra chatali geli hoti, ani nana jar asha gamja marat asel tar jya panjyane to dhamaki deto to panja chatla jail"--- "Maharashtratale yuvak atishay santapt aahet, Amaravatitun pore nighale aahet, Nananni apla panja vachavun thevava"--- Said conversation is available on SAM TV and TV9, Youtube channels.

2 The complainant further submits that accused No.2 intentionally with malic intention participated in agitation and gave media bites in Jalna District on 18/01/2022 saying that "mala ya tighana sangayache aahe ki Nana Patolichi masti vadhali aahe--- maza aplya sarvanchya sakshine evadhech sangayche aahe ki, Bhajap yuva morcha mhanun mi tumhala boltoy, magani kartoy ki Patolinchi Jeebh karnaryala ek lakh rupayache bakshish aaj amchya vatine ghoshit karto ---" This conversation is available on Times Marathi News and TV 9 Marathi. News reporter said to accused No.2 that Krishnabhav apan 5 divasapurvi Covid positive hote aaj apan lavajama ghevun ithe andolan karayala aale aahe, sarvajanik jababdarichya anushangane he yogya aahe ka? This conversation is available on ABP Maza, Nagpur Tahalaka, Lokmat, Esakal, ABP 9, Youtube channels. The accused are the part of criminal conspiracy. It is alleged by the complainant that they have committed offence punishable U/sec. 153, 153 A, 153 B, 188, 220 B, 269, 270, 271, 341, 500, 504, 505 (ii), 506 r/w 34 of The Indian Penal Code and under Disaster Management Act and the Epidemic Deceases Act.

3 The verification statement of complainant runs with this complaint. The complainant has filed copies of online news articles of TV9 Marathi, Loksatta, TV9 Live news. He has also filed copies of video clips of media bites given by accused to media in pen-drive. Offences alleged by the complainant against accused are alleged to have been committed by accused at Amaravati and Jalna. Accused No.1 is resident of Warud, Dist. Amaravat, accused No.3 is resident of Telipura Satrajipura, Itwari, Nagpur which is out of the jurisdiction of this Court. Address of accused No.2 is not known. Therefore, in view of mandatory provision U/sec. 202(1) of The Code of Criminal Procedure,

it is necessary to find out truth in the complaint filed by complainant. Hence, as per provisions U/sec. 202 of The Code of Criminal Procedure the complaint needs to be sent for investigation. Hence, I pass following order.

ORDER

- 1 Sr. PI of Azad Maidan Police Station, Mumbai is directed to investigate offences punishable U/sec. 153, 153 A, 153 B, 188, 220 B, 269, 270, 271, 341, 500, 504, 505 (ii), 506 r/w 34 of The Indian Penal Code against accused vide Sec. 202 of The Code of Criminal Procedure and submit its report till 23/03/2022 till then issuance of process against accused is postponed.
- 2 Issue letter to Sr. PI of Azad Maidan Police Station, Mumbai.
